The University of Manitoba campuses are located on the original lands of the Anishinaabeg, Ininiwak, Anisininewuk, Dakota and Dene, and the National Homeland of the Red River Métis. We honour the lands, waters, and relations that sustain us.

We are governed by the promises - most of them unfulfilled - of Treaty 1 and the Manitoba Act. We recognize that we have benefited from, and continue to benefit from colonization, specifically of Treaty 1 lands, but also Treaty 2, 3, 4, and 5 Territories.

We acknowledge that Winnipeg's drinking water comes from Shoal Lake, waters that have been stewarded by both Iskatewizaagegan No. 39 and Shoal Lake 40 First Nations. Sourcing Winnipeg's water from Shoal Lake led to Shoal Lake 40 lacking access to clean drinking water for more than two decades. Many First Nations communities do not have clean drinking water, not only because of a lack of Western water infrastructure, but because settler colonial violence to the land has polluted their traditional water sources. You can learn more about the development of Winnipeg's municipal water supply as an example of the history of settler colonialism in Dr. Adele Perry's book *Aqueduct: Colonialism, Resources, and the Histories we Remember*.

We also acknowledge that our access to electricity comes from the north, particularly Treaty 5 territory but also Treaty 1, 2, 3 and 4. This access to hydroelectricity often results in the displacement of Indigenous peoples and their communities, including flooding, shoreline erosion, changes to water quality, disruption to fishing and hunting, and the destruction of habitat.

We offer this acknowledgement to promote a shared understanding of the history that has led us to this moment. The CHRR recognizes the ways in which other systems of oppression intersect with colonialism to deny the rights of Indigenous peoples and communities. Our history is a history of colonial violence, Indigenous dispossession, and environmental harm, as well as of Indigenous resistance, knowledges, and resurgence. The CHRR uses an intersectional lens to research and advocate for Indigenous sovereignty and resurgences.

Section 1

General Background

1.1

Mission and Objectives

Established in 2012, the Centre for Human Rights Research (CHRR) is an inter-faculty initiative at the University of Manitoba, supported by the Deans of Arts, Law, Social Work, and Education.

Following our 2023 Strategic Planning workshop, CHRR Affiliates, staff, and students collaboratively created a new Vision Statement for the Centre. This vision, alongside the University of Manitoba's Strategic Research Plan, has helped inspire the work and goals of the CHRR for 2023-28.

Mission

CHRR was established in 2012 to bring together people and organizations - both within and outside the University of Manitoba - to enhance interdisciplinary and collaborative research capacity, create richer training opportunities for students, and facilitate the fusion of research-driven knowledge, public policy and intellectual debate on issues related to human rights and social justice. The centre aims to facilitate research that is both academically rigorous and accessible to the public.

Vision

CHRR uses an intersectional lens to research and advocate for human rights and Indigenous sovereignty and resurgence. We work with researchers and communities inside and outside of the University of Manitoba to develop and foster a wide variety of research that is informed by social justice.

CHRR is led by Academic Director **Dr. Adele Perry**. Dr. Perry is a distinguished professor of History and Women's and Gender Studies at the University of Manitoba. She is a historian of colonialism and imperialism, transnationalism, gender, sexuality, racism and western Canada in the 19th and 20th centuries.

2.1.3 Staff

CHRR has one full-time staff position (Manager) held by **Dr. Pauline Tennent**. Dr. Tennent has fifteen years' experience working in research on issues including social justice, reconciliation, and healthcare. Before joining CHRR, Pauline worked at the College of Nursing (UM), the Canadian Museum for Human Rights, and the Arthur V. Mauro Institute for Peace and Justice (UM).

One part-time staff position (Office Assistant) supports the Centre's work and is held by **Denise Boissoneault-McInnes**.

Since the Fall of 2023, CHRR has benefitted tremendously from a part-time, temporary Community Engagement Assistant position. This position, held by **Angela Ciceron**, was responsible for coordinating events and outreach, and assisted with the development of human rights resources accessible to the public. In 2024, in response to the changing research landscape, and with the financial support of the University of Manitoba's Strategic Initiatives Support Fund, we were able to reframe this position as a Knowledge Mobilization Coordinator, assisting the manager in designing and implementing strategies and outputs to make human rights research accessible and useful. Funding for this position will end in March 2025.

The CHRR contributes to research training and mentorship through part-time student research assistant positions. In 2024, we were able to support **22 students** in a temporary, part-time capacity. Each position averages 5 hours per week, though for some projects and/or funding initiatives, students worked as many as 30 hours per week. These positions are largely dependent on funding opportunities including the **Work Study Program** (3 students); **Indigenous Summer Student Internship Program** (1 student); **Faculty of Law Endowment Fund** (2 students); **IGNITE funding** (4 students) and the **UM Strategic Initiatives Support Fund** (5 students). We supported 6 students with external funding (i.e., Tri-Council Agencies), and an additional 2 students through CHRR's Operating Budget.

In 2024, the CHRR hosted **Sandra Delaronde** as Visiting Community Researcher (nil-salaried). Sandra is the project lead of **Giganawenimaanaanig**, the Manitoba Implementation Committee for the Calls for Justice. Sandra's position will continue into 2025.




Fig. 1: Composition of CHRR Affiliates by University or Institution





Fig. 2: Composition of CHRR Affiliates from UManitoba by Faculty



2.1.4 General Membership

CHRR has a network of more than 85 Research and Professional Affiliates, from within and outside the University of Manitoba (Figure 1 and 2; see Appendix 1 for a full list of Research Affiliates). Members have access to administrative, communications, and knowledge mobilization assistance from CHRR; support with grant writing; opportunities for networking and collaboration; and participation in the CHRR’s Small Grants Program. The range of involvement for the various members varies widely. Notably for this year:

- **2 Affiliates** (Perry and Ladner) lead SSHRC-funded Connections grant “At the Forks: Where Indigenous and Human Rights Intersect” (administered by CHRR).
- **3 Affiliates** (Perry, Larios, Smith) and CHRR Manager (Tennent) led the UM-funded “Period Poverty and Equity, On Campus and Beyond” project (administered by CHRR).
- **1 Affiliate** (Wilson) leads the SSHRC-funded Connections grant “Water and Climate Justice SSHRC Connection grant (CHRR is a collaborator)
- **3 Affiliates** (Carleton, Perry, and Thorpe) collaborate on the SSHRC-funded Knowledge Synthesis Grant “History in the Hot Seat: The Knowing and Teaching of Canada’s Past”
- **8 Affiliates** (Perry, Farenhorst, Jayme, Ladner, Nixon, Thompson, Thorpe, Wilson) collaborate on the UM-funded “Just Waters: Thinking with Hydro-Social Relations for a More Just and Sustainable World.”

2.3 Equity, Diversity, and Inclusion

CHRR considers EDI a philosophy, a practice, an ethos, and mode of everyday conduct for transforming inequitable relationships. In this way, we work to ensure the Centre's activities are attentive to a) historically underrepresented groups, b) histories and current experiences of oppression, with attention to the ways that COVID-19 has intensified inequities, and c) efforts to enhance diversity in the academy.

We recognize that our permanent positions are at present staffed by white, settler, cis-gendered women, and acknowledge this positionality in our work. We work to ensure that our hiring, networking, research, events, and outreach are anti-racist, anti-oppressive, and accessible contributing to the possibilities for transformation. To consider our hiring practices for student trainees, an overwhelming majority of students CHRR has hired as research assistants belong to one or more marginalized groups designated by the university for inclusion efforts: women, racialized persons, Indigenous peoples, people with a disability, and people of all gender identities and sexual orientations (95% in 2024). CHRR has a strong record of hiring and mentoring Indigenous students in numbers much higher than their proportion of the UM student population. For example, about a third of more than 100 trainees in a science research training program CHRR co-managed identified as Indigenous. Where non-Indigenous and/or settler staff and students are hired, we ensure that they can develop skills around intercultural competency, human rights, and anti-racism (following the Final Report and Recommendations of EDI Task Force; and Recommendation 2.4 UM Indigenous Senior Leadership Report).

2.4 Truth and Reconciliation Calls to Action

The Truth and Reconciliation Commission’s Calls to Action, as well as the Calls for Justice from the National Inquiry for Missing and Murdered Indigenous Women and Girls (MMIWG2S+) are woven into the fabric of CHRR’s daily practice. Our annual budget has prioritized funds specifically for events and outreach activities that contribute to the journey of reconciliation and to the calls for educators. Specifically, we have organized and/or co-sponsored events in collaboration with Indigenous Engagement and Communications and Mamawipawin (as examples) for National Day for Truth and Reconciliation; Red Dress Day; and National Day of Action for Missing and Murdered Indigenous Women and Girls to educate and raise awareness of the issues. We have also created human rights based resources aimed at increasing learning around issues of reconciliation and colonialism in Canada including [resource guides on reconciliation](#); [guides for allies](#); [workshops on teaching about Canada’s colonial past](#); [blog posts on MMIWG2s+](#) and [National Day for Reconciliation](#); and [graphic recordings on reconciliation](#) as just a few examples. We also work to creating space and engage with Indigenous knowledge systems and the diverse voices of Indigenous peoples in Manitoba and across Canada through our events, outreach, and research activities.

Section 3 Research

The research conducted and supported by the Centre for Human Rights Research and its research affiliates and partners focuses on a variety of broad human rights and social justice themes. Current research themes include **Borders and Human Rights**; **Indigenous Peoples and Human Rights**; **Water Rights and Justice**; and **Reproductive and Bodily Justice**.

3.1 Facilitation of Research Transformation

► Collaborative Funded Projects

In 2024, the Centre administered three TriCouncil projects, led by Dr. Adele Perry, including:

- SSHRC Knowledge Synthesis Grant for a project titled “Missing the Bus: Indigenous Women and Two-Spirit Plus People and Public Transit in Western Canada” (\$29,144)
- SSHRC Connections Grant for a project titled “At the Forks: Where Indigenous and Human Rights Intersect” (\$21,308)
- SSHRC Knowledge Synthesis Grant for a project titled “History in the Hot Seat: The Knowing and Teaching of Canada’s Past” (\$30,000)

In 2024, CHRR received additional funding through:

- the University of Manitoba’s Strategic Initiatives Support Fund for “Bridging the Gap between Human Rights Research and Practice” (\$56,986.00)
- Research Manitoba’s Connections Grant for the international conference “Pride in Health” (\$4,500) with additional cash and in-kind contributions from UM departments, faculties, and units (\$16,000).
- the University of Manitoba’s IGNITE program for “Just Waters: Thinking with Hydro-Social Relations for a More Just and Sustainable World” (\$1,049,510.00)






Fig. 3: CHRR event reach from January-December 2024

► Events and Outreach

In line with our mission to facilitate the fusion of research-driven knowledge, public policy, and intellectual debate on issues related to human rights and social justice 2024, the CHRR hosted 35 public events (virtual and in-person) on a range of issues to a combined audience of more than 1,650 attendees. Many of these events were at full capacity. A full list of events organized by the CHRR can be found in Appendix 2. Many of these events were recorded and can be found on our YouTube Channel.

Throughout the year, CHRR offers networking events for Affiliates, including space for affiliates to present their “Works in Progress” to gain feedback and explore interdisciplinary collaborations. In the past year, CHRR has also supported grant applications from CHRR Research Affiliates. This support looks differently depending on the project and has included grant writing and/or editing, in-kind financial support, administrative support of research and outreach, and/or support with knowledge mobilization.

3.2 Impact on Programs and Policies

The “Period Poverty and Equity, On Campus and Beyond” project, supported by a Strategic Initiatives Support Fund grant (2023-24), with additional funding from the Faculty of Arts continues to raise awareness of menstrual inequities in the university setting and, in the community, more broadly speaking. The impacts of this project have been multifaceted: through our survey and outreach events, we received feedback on the importance for people to have a space to share their menstruation experiences, experiences that had otherwise been silenced, dismissed, or pushed to the private sphere; we have offered support and guidance to students at local high schools, as well as students and faculty at other Canadian campuses who are looking to explore menstrual equity in their contexts; student Research Assistants on the project were able to author publications and conference presentations based on their work; recommendations from the project were submitted to the University of Manitoba who are looking to expand the free menstrual supply pilot program; collaborations were forged with [Moon Time Connections](#) to explore issues of water and menstrual justice on for Indigenous menstruators in Canada; and new collaborations including with the Queer and Trans Graduate Student Group (as one example) emerged, working together on the [Pride in Health](#) conference (October 2024).

3.3 Top Transformative Product

This past year, we were honored to work alongside Indigenous Engagement and Communications at UM for two events that were rooted in the National Inquiry into Missing and Murdered Indigenous Women, Girls, and Gender Diverse Peoples' Calls for Justice. In May 2024, we hosted [Cambria Harris for a lecture](#) in honour of Red Dress Day. In October 2024, we hosted Dr. Sherry Farrell Racette for a lecture and community-based beading workshop. Both of these events were attended to capacity and had a far-reaching impact. They have generated ongoing awareness of violence against Indigenous women, girls, and gender diverse people and attention to the Calls for Justice among the university community. They have inspired additional research and knowledge translation from CHRR, include a [resource guide on MMIWG2S+](#), as well as the drafting of a [policy brief on human rights implications of public transportation \(or lack thereof\) on Indigenous women, girls, and gender diverse people](#). This work has also helped inspire a funding application to SSHRC, working alongside **Sandra Delaronde** to synthesize knowledge on the impact of colonialism on Indigenous women in governance and leadership.

3.4 Other Activities

CHRR operates an annual [Small Grants program](#) for new, interdisciplinary human rights research projects. In 2024, recipients Drs. Merissa Daborn (Indigenous Studies), Bruno de Oliveira Jayme (Education), and Christine Mayor (Social Work) continued work on their Small Grant projects. Dr. Qiuyan Yuan (Engineering) began work on their Small Grant project in December 2024.

4.1 Training and Mentorship Activities Facilitated by CHRR

In 2024, we were able to offer part-time, temporary student research assistant positions to 22 students. Students contribute to event promotion and support, research and literature reviews, blog posts, and outreach (both internal and external). They gain skills in research, communication, knowledge mobilization, and project administration.

4.2 Professional Development and Training Provided by CHRR

With funding from the Faculty of Law Endowment Fund, CHRR's [Speakers Bureau](#) program assists Manitoba teachers in educating their students about human rights issues. In 2024, CHRR volunteers made presentations to 11 classrooms as well as non-governmental organizations across Winnipeg, to students from Grades 4-12.

The CHRR also offers a workshop series entitled [Methods + Mediums](#), that focuses on research methods, methodologies, and approaches to knowledge mobilization in human rights and social justice. These workshops have provided UM students, faculty, and staff with introductions to topics such as Open Access Publishing, a Deaf-centric approach to research, and research using the archives.

Section 5 Future Plans

5.1 Main Objectives and Initiatives for Upcoming Year

In line with our Strategic Plan, objectives and goals for the upcoming year include:

Enhance the CHRR's support for research and researchers;

i.

Grow the CHRR's network on- and off-campus;

ii.

Strengthen the CHRR's public presence; and

iii.

Build the CHRR's institutional capacity.

iv.

In the upcoming year, we plan to apply for additional funding opportunities to expand research, training, and community outreach at the Centre. All of these initiatives will have as a key component the creation and sharing of research outputs that are accessible to the public. We will work to expand our resource hub including the release of our Just Research podcast and support the knowledge mobilization activities of the Just Waters research project.

6.1 Summary of 2024 Finances

The Centre for Human Rights Research received \$215,320.00 in Operational Funds for the 2024-25 fiscal year.

In the past, the Centre has operated from a deficit, relying on either a deficit or Carryover funds to maintain the Centre’s work. However, this year, we were able to utilize funding from the Strategic Initiatives Support Fund, as well as Tri Council Grants, to fund events and outreach, support staff positions, and training positions for students. However, as this funding comes to an end, and as costs associated with travel, events, and collaborations continue to rise, our general operations will be limited by budgetary constraints.

The Centre for Human Rights Research is grateful to the Faculty of Law at Robson Hall for their generous support in terms of space, as well as in-kind support (ex. technical support, office supplies).

Section 6 Finances

6.2 Summary of 2025 Projected Finances

For many years, CHRR has relied on Carryover Funds to supplement its operational costs. Changes to the University of Manitoba's policy on carryover will impact the Centre's work. As such, our operating budget for the upcoming year will be focused on maintaining the permanent staff positions and exploring ways to make the Knowledge Mobilization position permanent given its essential nature in the operation of a research centre. Funds will be earmarked for outreach related to the Calls to Action and Calls to Justice and for student training through research assistant positions, in line with the University of Manitoba's [Strategic Plan \(2024-29\)](#) and [Strategic Research Plan \(2024-29\)](#).

Section 7 Challenges

7.1 Challenges Experienced and Potential Challenges Upcoming

Since its launch in 2012, CHRR has relied on the generosity of the Faculty of Law for its office space and basic office supplies. Our current agreement with Robson Hall ends in 2027. Moving forward, we will look to begin discussions with units on campus about a future home for the CHRR.

The University of Manitoba's Strategic Research Plan (2024) prioritizes issues that are key to CHRR's work: human security and equity, Indigenous research, health and well-being, sustainability; and water security. Interdisciplinary approaches for dealing with these wicked problems have been recognized as the most appropriate and effective ways of dealing with such issues. The CHRR is well-placed to become a leader in fostering such approaches, however, structural barriers and the silo mentality of faculties hamper the potential for meaningful and effective collaboration in this work. Funding pressures have exacerbated the situation, with faculties looking for ways to trim expenses that are not essential to their core teaching mandate. We are hopeful that recent initiatives at the University such as IGNITE, will work to enhance interdisciplinary approaches to the human rights issues of our times.

CHRR receives multiple requests from students for employment and training positions; as well as requests for collaboration with internal units and external community partners on research and outreach activities. While the Centre works hard to meet these requests, it is increasingly difficult to do so and indeed to expand within the context of our current operating budget.
